

AGREEMENT OF FEES ENTERED INTO AND BETWEEN:

Urfirst Makelaars (Pty) Ltd Trading as Pinnacle Primary & Secondary Boarding School (Hereinafter called the "School")and

Whereas the responsible person is longing for the school to educate and care for

and whereas the school is willing to accommodate the said learner.

RESPONSIBLE PERSON meaning any person acting on behalf of the learner whether it is the guardian, parent, uncle or whatsoever, where acting as a agent, the responsible person binds him or herself as a surely an co debtor.

THE PARTIES AGREE AS FOLLOWS:

- 1.The school will educate and care for the learner in accordance to the Independent Schools Association of Southern Africa's accepted rules and regulations abiding to all laws and bylaws which may be applicable to the said school on an basis to be advised to the responsible person by means of regular circulars to be handed out to the responsible person on out weekends.
- 2.The responsible person will be obliged to pay required school fees regarding the learner each month before or on the 15th of that specific month. (Ex. 15 January 2005 is the last day to pay the fees for January 2005.) The required fees will be advised to the responsible person at the beginning of each month in the form of a statement, which must be collected at the office when learners are fetched for out weekends.
- 3.The responsible person will be liable to pay a registration fee on acceptance of the said learner at the school. This is a NON REFUNDABLE fee and will not be refunded if the responsible person decides not to bring the child to the school. The registration fee must be paid each year when you re-apply for place for your child.
- 4.The responsible person will be obliged to make payments for school fees for periods which the learner is not in school due to for instance illness, personal problems etc.
- 5.If the responsible person elects to remove the learner from the said school, the responsible person will be obliged to give one months written notice on or before the 1st day of the final month.
- 6.The responsible person agrees to abide by the weekend program, which will be handed out to the responsible person regarding out weekends. The responsible person agrees to pay an extra amount of R350 per out weekend if the said learner is not removed from the school for the out weekend. There will only be one out weekend per month.
- 7.The responsible person or his agent is required to fetch the learner and bring the learner back on the time and dates as specified on the roster regarding out weekends.

8.If the said learner is not fetched or brought back at or before the times as specified on the out weekend roster, then such responsible person shall be liable to a penalty which will be calculated at R100 per hour for each hour the learner is late.

9.If the payment of school fees is late, then such responsible person shall be liable to a penalty of R150. If the payment of school fees is behind with 1 month, the said learner will not be allowed back after a out weekend.

10.The responsible person agrees to abide by the rules of the school and to promote such with the learner.

11.The responsible person indemnifies the said school and such school will not be held responsible for any injuries or accidents, which may occur whilst the earner is in the care of the school.

12.The responsible person chooses as his/her domicilium citandi et executandi the address as chosen on the application form for any legal action.

13.The responsible person agrees that a garnishee order may be applied for the magistrate's court for the full outstanding amount owing for school fees if the responsible person fails to make the required payments of fees on or before the due dates as agreed between the parties.

14.The school undertakes to care and protect the learner to the best of their abilities and to provide quality education in an academic surrounding.

15.This is the whole of the agreement for fees entered into by the parties and no addition or alteration hereto will have any lawful effect unless such alteration or addition is put in writing and signed by both parties.
